President's Corner (ctd)

NEIGHBORHOOD CRIME FOCUS OF NEXT CIVIC ASSOCIATION MEETING

At the beginning of October, we had a rash of burglaries in the neighborhood, with several of our neighbors victims of break-ins and theft. A suspect has been arrested and on last report another suspect has been identified but not yet arrested. Since the arrest, the burglaries in Douglas Park have apparently stopped, and the number of burglaries in South Arlington generally has dropped significantly. This is good news, but we should not assume that the problem will never return.

The next civic association meeting, on Tuesday, November 17 at 7.30 pm in the Randolph Elementary Cafeteria will focus on crime prevention. The police department will be attending, with information on crime prevention—particularly burglary prevention. We also want to see what we can do about establishing a neighborhood watch or some other way to use our collective vigilance to keep our homes safe and secure. As a community, we watch out for each other in general, but there may be more that we can do. Criminals get caught because somebody sees something and calls the police. How can we watch over our community more effectively? To succeed, any such effort will need widespread participation, starting with attending the Nov 17 meeting.

MISSING SIDEWALKS

If you are interested in correcting a 'missing link' of sidewalk — typically a stretch of I to 3 houses with sidewalk missing in front, Arlington Neighborhood Conservation is accepting applications through the end of November. Occupancy Code: Overcrowding and Occupancy Limits

NOTE: The Arlington County Code Enforcement Office investigates complaints and issues notices to owners/landlords to correct violations. Portions of the Code are cited below for interest only. YOU do not have to interpret the Code, that's their job. Just call them with a complaint at 703.228.3232 or 703.228.3883

Regulating occupancy is a complicated and often unclear set of rules divided between Arlington County Code and the Virginia Unified Statewide Building Code (VUSBC).

Arlington County Code limits occupancy to no more than four unrelated adults. If residents are related, occupancy is determined by the VUSBC which says each bedroom for one person must contain at least 70 sq ft. A bedroom for more than one person must contain at least 50 sq ft of floor area for each occupant.

Living rooms and dining rooms are not allowed to be included in the calculation for sleeping space. Kitchens and nonhabitable spaces (bathrooms, toilet rooms, closets, halls, storage or utility spaces, and similar areas) are not allowed to be used for sleeping space.

The following are the relevant portions of the 2006 VUSBC.

404.4. Bedroom requirements. Every bedroom shall comply with the requirements of Sections 404.4.1 through 404.4.5. **404.4.1 Area for sleeping purposes.** Every bedroom occupied by one person shall contain at least 70 square feet (6.5 sq m) of floor area, and every bedroom occupied by more than one person shall contain at least 50 square feet (4.6 sq m) of floor area for each occupant thereof.

404.4.2 Access from bedrooms. Bedrooms shall not constitute the only means of access to other bedrooms or habitable spaces and shall not serve as the only means of egress from other habitable spaces.

Exception: Units that contain fewer than two bedrooms.

404.4.3 Water closet accessibility. Every bedroom shall have access to at least one water closet and one lavatory without passing through another bedroom. Every bedroom in a dwelling unit shall have access to at least one water closet and lavatory located in the same story as the bedroom or an adjacent story.

404.4.4 Prohibited occupancy. Kitchens and nonhabitable spaces shall not be used for sleeping purposes.

Occupancy Code (ctd):

404.4.5 Other requirements. Bedrooms shall comply with the applicable provisions of this code including, but not limited to, the light, ventilation, room area, ceiling height and room width requirements of this chapter; the plumbing facilities and water-heating facilities requirements of Chapter 5; the heating facilities and electrical receptacle requirements of Chapter 6; and the smoke detector and emergency escape requirements of Chapter 7.

404.5. Overcrowding. Dwelling units shall not be occupied by more occupants than permitted by the minimum area requirements of Table 404.5.

Occupancy Code (ctd):

404.5.1 Sleeping area. The minimum occupancy area required by Table 404.5 shall not be included as a sleeping area in determining the minimum occupancy area for sleeping purposes. All sleeping areas shall comply with Section 404.4.

404.5.2 Combined spaces. Combined living room and dining room spaces shall comply with the requirements of Table 404.5 if the total area is equal to that required for separate rooms and if the space is located so as to function as a combination living room/dining room.
