## What's Wrong with English Ivy?

Arlington volunteers are removing a lot of English ivy from county parks these days, along with other invasive plants. Why do we bother? After all it's attractive, cheap, and easy to grow. Once established it requires little maintenance.

English ivy is bad for our parks, as it turns out. Once it 'escapes' into our parks it spreads quickly, overwhelming native vegetation. (Next time you walk through Douglas Park or Doctor's Run look around and you will likely see it everywhere.) It provides little wildlife value. It competes with trees for water, light and nutrients. It inhibits the growth of tree seedlings and therefore threatens our future forests and parks.

How did English ivy get into our parks, you ask? Good question! If English ivy grows up a tree, once it gets a few feet up in the air it will flower and fruit. The berries can be hard to spot from the ground but the birds love them. If you have found a bit of ivy growing in your yard a bird excreted the seed. This is a big reason to cut ivy from trees: to stop the further spread. If your yard adjoins a park it can also spread on the ground from your yard (or to your neighbor's yard!).

This is not to say English ivy should be eradicated completely. But it should probably be restricted to small and isolated spots, such as a courtyard or patio. And having it grow up a tree is bad for the tree and bad for our parks.

Arlington County is so concerned about controlling English ivy and other invasive plants in its parks the county has an Invasive Plant Control Program Coordinator. For more information please contact Sarah Archer at 703.228.1862 or by email at *sarcher@arlingtonva.us*.

### **NEXT CIVIC ASSOCIATION MEETING 17 APRIL**

The next Douglas Park Civic Association meeting will be on Tuesday evening, 17 April 2012 at 7:30p at Café Sazon, 4704 Columbia Pike, near Goodwill at Columbia Pike and South Buchanan Street.. The agenda will include:

- Election of Civic Association Vice President. Tina Worten and Colin Winkler have been nominated for the position of vice president. The main duty of the civic association vice president is to chair meetings in the absence of the president, but our vice presidents also take on other projects, such as helping with events (4th of July Parade and Picnic, Election Day Bake Sale, etc).
- **Phoenix Bikes.** Our neighbor Henry Dunbar, executive director of Phoenix Bikes, will give an overview of the organization and their ongoing fundraising efforts.
- 4th of July Picnic. We will discuss preparations for the main event—the 4th of July Parade and Picnic—and appoint a volunteer recruiter/coordinator.

- Community Development Citizens Advisory Committee. Community development block grants certain county programs are targeted to particular neighborhoods with large numbers of people with low incomes (Neighborhood Strategy Areas). Part of Douglas Park is an NSA, so we get representation on the committee that advises the county on how to provide the funding. Neighbor Chani Wiggins has been nominated for that position, and we will take up her appointment.
- Bike Boulevards. County Transportation Department staff will update us on the creation of 'bike boulevards' on 12th Street South (and 9th Street South) to provide a route for bikes parallel to Columbia Pike.

#### CIVIC ASSOCIATION UPDATE

• Elections. At the last civic association, the following officers were re-elected by acclimation:

> John Snyder, President Annette Pigott, Secretary Al Fox, Treasurer

- 16th Street Traffic Calming. An update on the plans for traffic circles on 16th Street South was presented by County Transportation staff. The circles at the intersections of South Nelson, Oakland and Pollard Streets with 16th Street, will be slightly smaller than previously planned, to allow room for traffic to pass by, while extending the street corners to accommodate ramps on the sidewalks compliant with the Americans with Disabilities Act. Under the new plans, no property will need to be taken from the vards of any residences. Clearances for vehicles will remain sufficient for easy passage of emergency vehicles.
- Columbia Pike Land Use and Housing Study. We received an update from County Planning Department staff on ongoing efforts to develop the Neighborhoods Plan for the Pike. The goal is to develop a plan to govern redevelopment in the areas of the Pike between the major intersections and commercial areas. Those areas are governed by the Form Based Code, which allows more density (bigger buildings) than would otherwise be allowed, provided the building is built to the standards required by the Form Based Code. These standards require ground floor retail, dictate the size of the building, etc. The Neighborhood Plan will dictate how big any new buildings along the Pike will be allowed to be, and also where within the development the height will be allowed.

## **President's Corner**

**CIVIC ASSOCIATION UPDATE**

A larger building along the Pike would intrude less than one on a back street next to single family homes, so the location of the main part of the building, and tapering to be closer to the size of the neighboring houses, are expected to be part of the plan. The plan will also address issues like where to locate green space, such as plazas, and where retail would be allowed/required, so that shops are within walking distance of residences.

One of the goals of the Land Use and Housing Study and Neighborhood Plan is to preserve affordable housing along the Pike. The goal is to preserve 100% of apartments currently affordable for people making 60% of the area median income, and at least half of the apartments affordable for people making 80% of the median. This would preserve affordability for about 5,000 apartments. About 2,300 market rate affordable apartments are in Douglas Park right now. Among the tools for preserving affordability are potential changes in zoning such that larger buildings would be allowed, provided they maintain a high percentage of the units as affordable. The more expensive apartments would subsidize the affordable units. Additional density to

make this possible would be located along the Pike, not looming over the neighborhood. As always, the question is how much density/height of buildings is appropriate in particular areas.

The draft Neighborhood Plan policy is to be released some time in April 2012. The current plan is to present it for approval to the County Board in June. If this policy statement is approved by the Board, County Staff would then develop a new form based code for the residential areas along the Pike, which would regulate future development in that area. Form based codes are established block by block, recognizing that in a particular spot, a larger or smaller building would be appropriate. We should expect this new form based code for the residential areas to borrow elements from the Form Based Code already in force for the commercial areas.

It is important to note that the idea of a form based code is to expedite approval of compliant projects. Since the neighborhood and county have established the requirements in advance, a project that meets the requirements is approved, without the freedom to modify it, and negotiations, that come with a site plan project. So we need to make sure the new form based code is right when it is adopted.

An issue with the Land Use and Housing Study that requires continued vigilance is the ratio of parking to be allowed in new buildings. A ratio of r<sup>1</sup>/8 parking spaces is required for new buildings under the current Form Based Code. Some people advocate a lower ratio to make new development less expensive, but it has not been demonstrated that a lower ratio would work. Many worry that the current ratio is too low. In any event, adding any new density means adding more people who need to get around. Therefore, upgraded transit for the Pike is necessary if any substantial amount of density is to be added along the Pike. We can't just add more cars to the Pike and to our neighborhoods.

• Rosenthal Site Re-Development. An application under the Form Based Code to re-evelop the Rosenthal car dealership site on the southeast corner of Columbia Pike and Glebe Road will be before the County Board at its 21 April meeting. The plan is for a 6 story building on the corner, with ground floor retail all along the Pike and South Glebe Road. On the back (south) side of the building, the frontage will be 31/2 stories, like a townhouse, but with apartments inside. A new block of 44 townhouses, also 3½ stories, is proposed for the block between South Glebe Road and South Monroe Street, a new 11th Street South, and a new 12th Street South where the post office driveway is now. 12th Street South will not connect to the development until it is re-built by the county, in the same location as the driveway, after arrangements to return that land for county use are made with the post office. The new 12th Street South will extend no further than the driveway does now. It will provide access to the post office, but end short of South Monroe Street. A bicycle and pedestrian path will still be in the same location it is now.


